




New policy for solar power generation in July





Overview

The “One Big Beautiful Bill Act” — budget reconciliation bill signed into law on July 4 — and a new Executive Order (EO) have clarified that solar and wind generation. After marathon floor debates and record-breaking vote lengths, the bill cleared the House on July 3, just in time to. We expect 63 gigawatts (GW) of new utility-scale electric-generating capacity to be added to the U. power grid in 2025 in our latest Preliminary Monthly Electric Generator Inventory report. This amount represents an almost 30% increase from 2024 when 48. President Trump issued an Executive Order on “ Ending. — Today the Solar Energy Industries Association (SEIA) is unveiling a new policy agenda that details the critical actions that local, state, and federal leaders must take to strengthen the reliability of America's electric grid with solar and storage technologies.
