Most states provide legal protections for solar installations while allowing reasonable restrictions, and conflicts can be resolved through communication, HOA procedures, mediation, or legal action when rights are violated. Before you object to a neighbor's solar panels, understand the balance between individual property rights and broader renewable energy regulations. Complaints about glare and aesthetics, especially if you live in a residential estate or complex. 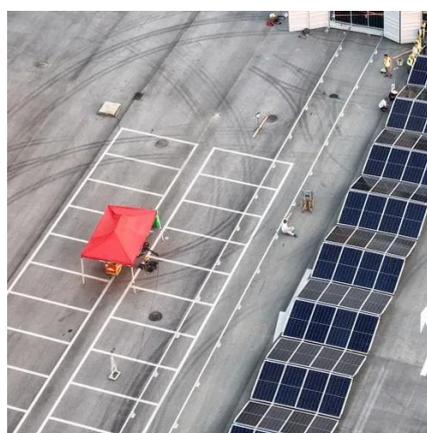
