



# Vietnam solar Power Direct Sales





## Overview

---

The new system establishes a direct power purchase agreement (DPPA) mechanism, enabling renewable energy producers to sell electricity directly to large consumers rather than through Vietnam Electricity (EVN). Decree 80, issued in July 2024, was Vietnam's first attempt to formalize. Decree 57/2025/ND-CP (“Decree 57”) introduces capped tariffs, rooftop solar limits, and wholesale market integration for Vietnam's renewable energy sector. Let us understand the new compliance, pricing, and infrastructure challenges that this decree brings. Wind, biomass, micro-hydropower, geothermal, wave, and tidal. On July 3, 2024, the government of Vietnam approved Decree No. Decree 57 took immediate effect and replaces Decree No.
