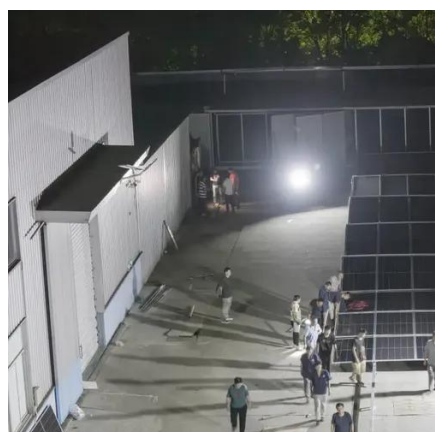

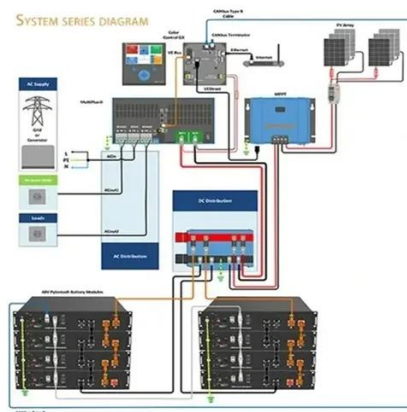
## State Licensing Requirements
